#### **TARYN DAVIS Executive Director, American Widow Project** 2017 TSNA Guest Speaker



At 21, Taryn received devastating news: Her husband, CPL Michael Davis, had been killed in Baghdad, Iraq. While her family provided all the support they could, she still felt lost and alone. When her Google search for "widow" turned up the result: "Did you mean window?" she knew she had to take action. Taryn created the American Widow Project to provide vital empowerment and peer-based resources to our Nation's Military Widows and Widowers, having now served over 2.000 at over 100 retreats.

Her passion and work with the AWP has been featured in such places as The TODAY Show, NPR, People and PBS. It's also led to her receiving such accolades as Top 10 CNN Hero, one of NEWSWEEK's 150 Women Who Shake the World, L'Oréal's National Woman of Worth and DVF People's Voice Award Recipient. She's shared her story on the stage for Forbes, GE, Morgan Stanley, TEDx and more.

I was very fortunate that I (an amateur who had served as Treasurer of other organizations) replaced someone who was extremely knowledgeable (and a professional accountant), Lois Fry, wife of the Director of Membership, Larry Fry. I encountered some interesting aspects in the TSNA system, and Lois was a strong support as I worked my way through it. I will always be grateful to Lois for her "expanding" my accounting finesse, and her tolerance of my many questions. Circumstances have since permitted us to simplify our accounting system, and no, my replacement need not be a CPA!

Bottom line is that TSNA has been in good financial shape for the past eight years, and we intend to keep it that way and, as long as the organization exists, to try to "do good" with our excess funds.

Our first major example of "doing good" was with the placement of the TSNA Memorial in Dayton in 2012. Our members were so generous with their financial support of the memorial that we ended up with an "overage" of funds. Those are the funds (with continuing contributions) that are used to finance a memorial plaque (or other form of remembrance) in each of our reunion cities since then.)

A newer program, which has my 100% personal and professional support, is the Scholarship Fund. Perhaps it is the stage of life we have all reached, but I look to these young people to whom we are giving a helping hand, as a "light of hope"-good luck to them. And may the small contribution we are making to their education reap many benefits for them and their follow-on generations. (Cure for cancer? For Alzheimer's? The next great invention? We as a group might be part of something major like that.)

THE FUTURE: We have a range of ages among our members, but there is a commonality: we are getting older. And the inevitable will happen. I have shared with the Board my experiences with a WWII group that had a very active and cohesive "next generation" element that intended to "carry on" the traditions and heritage of their parents. A great idea, but even with their enthusiasm, it did not work. Sooner or later, one of us will have the last glass of brandy and toast the memories of the rest of us.

What to do with the TSNA funds? (By that time, I hope they will be significantly lower than they are now; there is no need to "sit on" unneeded funds for another 15+ years.) The most obvious (and perhaps the most emotionally satisfying) ideas

may have problems that are not readily apparent. I strongly suggest that TSNA start looking at alternatives and investigating them.

Working on my first reunion, this year's gathering in Colorado Springs, I feel that I have overcome a number of potential obstacles to this event. The first was the location itself. We had never held a reunion this far West, and it was felt that we wouldn't be able to assemble enough of our members to make it worthwhile. I am happy to report that was some "fake news," to borrow a current phrase. As of today, we have more members signed up than expected, and our numbers continue to grow with each passing day. Second, the costs involved with a gathering in Colorado were viewed as a bit higher on the price scale than what our members were used to. The U. S. House voted unanimous to pass the resolution. The resolution was made official on August 10, 1964 and gave broad authority to President Johnson to wage an undeclared war. Pandora's Box had been opened.

Aside from Congress' approval of the resolution, Vietnam was becoming well known with 23,300 troops in country. Casualties were 216 that year. No longer were they to be called "advisors", but now known as combat troops.

Lyndon Johnson was reelected President. Johnson's Great Society Program was started. The United States Surgeon General says smoking cigarettes is harmful.

Ford Motor Company introduced the Mustang. GI Joe doll for boys hits the market.



#### TSNA Scholarship Recipients News Release Fall 2017

Two high school students – one from Texas and the other from Florida – have been selected as the latest recipients of \$5,000 scholarships from the Tan Son Nhut Association.

The TSNA Scholarship winners are Robin Ellis of Austin, Texas, and J. Slade Lucas of Gulf Breeze, Florida. Both had grandfathers who served in Vietnam.

Ellis plans to enroll at Mississippi State University in Starkville, MS, in the fall to pursue a degree in Civil Engineering. She has been accepted into the Air Force ROTC program at Mississippi State and plans to be involved in various "... groups that focus on helping others." She has been involved in community service groups during her high school years.

Lucas' higher education destination is the University of Florida in Gainesville, FL, where he will major in Bio Chemistry and Bio Mechanics. He said in his application essay that he was inspired to pursue this area of study by his sister who was born with a disability. His hope is that upon completion of his college work he will be able to be "...a part of helping to develop further advancements that might benefit people like my sister."

Ellis' grandfather was a career Air Force officer, serving 23 years on active duty. He was a pilot who, in addition to his service in Vietnam, also served in Operation Desert Storm.

Lucas' late grandfather served in Vietnam as a civilian employee of Telesignal and worked with the 1876th Communication Squadron at Tan Son Nhut Air Base for a total of 18 months over a four-year period. He was a manager for all 15 of the computer installation sites in Vietnam

The TSNA scholarships are paid in equal amounts for each of the student's four years in college as long as the student completes at least 30 semester hours of college work each year and maintains a B average.
